All education majors complete early field experiences prior to student teaching. Attempts are made to provide candidates with a variety of diverse experiences including schools with varying socioeconomic status, ethnicity, varying levels of access to and use of technology, rural and urban schools, special education populations, ELL students, and diverse grade band experiences. Additionally, candidates complete various assignments that require them to identify the diverse needs (including socioeconomic status) of their classroom, school and community. Candidates explore differentiated instruction to meet the needs of the diverse student population. Education majors complete observations as part of their early coursework. The majority of these observations in locations close to the institution, many of which are situated in low income areas with diverse student populations. The Teacher Education Advisory Council meets three times per academic year. Council members represent various school districts across the state. The council

provides the teacher preparation program with ongoing needs of the schools as well as new trends. This ongoing collaboration allows the teacher preparation program to make curriculum change to better meet the needs of the districts we work with.

The teacher preparation program continues to make intentional efforts to integrate technology into coursework and routinely assess candidate's use of technology in field experiences. The Teacher Work Sample is a key assignment completed by all education majors. this assignment requires candidates to use technology to collect and manage data, use the data to guide instruction, and evaluate the effectiveness of those changes. Candidates are assessed on their use of technology on their field experience evaluations during early field experiences and during student teaching. The Covid pandemic provided additional opportunities for candidates to immerse themselves in technology and leverage online platforms for teaching. Candidates reported using various technology apps, online assessments, and virtual learning environments to impact student learning.

Teacher Training

1. Provide a description of the activities that prepare general education teachers to:

a. Teach students with disabilities effectively

All teacher education candidates take Sped 226 "An overview course dealing with the various exceptional learners who might be mainstreamed into the regular educational program, both elementary and secondary. Emphasis is placed on understanding the exceptional learners as well as cooperative roles which educators must jointly fill in providing an appropriate education for exceptional learners". The course emphasizes provision of services to students with exceptionalities, in school and society. Additional guest speakers/workshops were added to familiarize candidates with the online IEP system. Secondary education majors participate in class activities on differentiating activities with respect to content, process, and product. Secondary candidates observe a collaborative classroom where a licensed content teacher works productively with a licensed special education teacher where all student's needs are met.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Elementary majors, take Sped 215-Behavior management - "This course provides the candidate with a practicum opportunity working with elementary students". Course assignment are designed to address the needs of students with exceptionalities who have behavior challenges. Secondary education candidates are encouraged to collaborate with host teachers on all aspects of teaching including as a member of individualized education program teams, sit in on team meetings, and reflect on those experiences in class assignments (Module responses from mentor teacher interviews, school personnel interviews, etc.). Coursework also incorporates simulation IEP meetings directed by a public school high school special education teacher with 'real life' redacted IEPs of students. Candidates have the chance to see how IEP meetings are conducted AND then how the content teachers make the accommodations and modifications for students in their classes.

c. Effectively teach students who are limited English proficient.

All teacher education candidates take a multicultural course which addresses the needs of students who are limited English proficient. Many elementary education candidates take a course on language acquisition as part of their minors. Elementary education majors are also exposed to and have opportunities to work with students with limited English proficiency in several courses throughout their program. For secondary education majors, one of the guiding texts used is the Association for Middle Level Education's This We Believe (NMSA, 2010) which tasks middle grades educators with providing an education that is developmentally responsive, challenging, empowering, and equitable. In class we have pointed conversations about how to define these four pillars and then we go on a tour of our host school led by middle school students themselves. When tasked with identifying aspects of the host school that are developmentally responsive, challenging, empowering, and equitable, conversations tend to sway towards very physical representations that were noticeable in the hallways and classrooms. This leads us to make the jump from visual examples to the everyday literacy practices that help students who are actively learning English through all of their classes. Secondary education majors participates in a seminar provided by a language instructor from the LLL department on ENL/ESL which comprises how to use literacy practices that help students who are actively learning English through all their classes.

a. Teach students with disabilities effectively

All special education majors or minors take the listed Sped 226-with the above information. All take Sped 215-with the same above information. Additionally, candidates learn strategies to support students with exceptionalities at the preschool level (Sped 203), elementary level (Sped 314 and Sped 318) and secondary level (Sped 400). The courses(Sped 203, Sped 314, Sped 318) have practicum hours associated with them. For Sped 314, the practicum is in an elementary resource setting and candidates work with students identified as having difficulties with math. A project of the course is to complete a CBA, analyze data, and research intervention supports to aid in math acquisition. For Sped 318, the practicum is in an elementary resource setting and candidates work with small groups or individuals in a resource room-who struggle with reading and language arts. The candidates used various learned strategies-to support student learning. The candidates also complete a lesson planning unit on applying UDL principles to support learners. In Sped 311, the candidates learn about assessment and special education, and complete a course project on applying the RTI model and researched interventions to a case study student. Elementary Special Ed. minors go through Total and received more experiences and expectations in Sped 402- Course Intent: The purpose of this course is to provide students with an opportunity to consider their beliefs about teaching and to examine their teaching methods and teaching styles, to compare them to effective teaching practices (Best Practices) in classrooms and in research. Students will practice creating and teaching lessons based on Indiana Academic Standards and other content area standards, as well as student interests and appropriate developmental levels. Students will mindfully differentiate instruction to meet the instructional needs of their students and will co-teach in a variety of settings.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Special Education majors and minors, take Sped 215-Behavior management - This course provides the candidate with a practicum opportunity working with elementary students. The candidates are required to complete a FBA and a BIP-which are important in supporting students with exceptionalities who have behavior challenges. The information gleaned from BIP can be a part of an IEP. Special education majors or minors also take Sped 321-special education law. The candidates complete an IEP, based on a case study student.

c. Effectively teach students who are limited English proficient.

All teacher education candidates take a multicultural course which addresses the needs of students who are limited English proficient.
