3d Finance Committee Report

3d1 Operating Budgets, 2018-19

Presented below are balanced operating budgets based upon estimates of tuition revenue, State appropriations, and other available sources for the fiscal year 2018-19. It is recommended the President of Indiana State University be further authorized to establish salaries and wages for the 2018-19 fiscal year within the capabilities of budgeted resources.

<u>Recommendation</u>: Approval of the following operating budgets for the 2018-19 fiscal year and authorization of the President of Indiana State University to establish salaries and wages within the capabilities of budgeted resources.

INDIANA STATE UNIVERSITY 2018-19 Budgets

The General Fund, Student Activity, Auxiliary and Other Operating Units, and Line-Item summary budgets for 2018-19 are described below along with the related key planning points as discussed with the Board of Trustees Finance Committee on February 23, 2018.

GENERAL FUND BUDGET

Revenues

Revenue projected for the 2018-19 General Fund budget totals \$195,300,000, as compared to \$189,300,000 in 2017-18. The change in revenue comes primarily from a general student fee increase for resident and non-resident students, the inclusion of academic program fees for certain graduate programs, an increase of \$2,610,642 for fee-replaced academic debt service, and other miscellaneous revenue adjustments including \$608,000 from interest income to offset costs related to debt service for the non-fee replaced portion of academic facility debt service.

The operating appropriation increased by \$419,341 from the 2017-18 level. The 2017 Indiana General Assembly appropriated a separate allocation of \$2,350,000 dedicated to Student Success Initiatives. Budgeted tuition for 2018-19 assumes an average of 100 percent of the undergraduate and graduate full-time equivalent enrollment of the previous two fall semesters. The increase in budgeted tuition is inclusive of a 1.95 percent tuition and mandatory fee increase (\$2,166,777). Overall, student tuition represents 55.1 percent of the total general fund revenues as compared to 40.7 percent for state support including operating and academic debt service appropriations. The remaining 4.2 percent represents other fees and charges, miscellaneous income and transfers.

To meet the priorities and commitments reflected in the budget, reallocations (reductions) were required as a part of the 2018-19 budget planning process. A total of \$662,339 was reallocated from 2017-18 base budgets to fund increases in compensation and other priority budget items including \$224,000 to support the newly created Honors College.

Expenditures

I. Compensation

The 2018-19 operating budget contains a projected 1.8 percent increase pool for salary adjustments inclusive of a 1.5 percent across the board increase for employees with good performance and amounts set aside for faculty and staff target salary programs. Criteria for any salary adjustments will be determined once enrollment numbers are known for the fall 2018 semester and an assessment of overall budgetary conditions has been made. Student wage departmental budgets were also increased by 1.5 percent overall.

Fringe benefit budgets allocated to each division of the University are annually realigned to more closely reflect actual expenditure patterns. The University provides eligible employees with a full benefit package which includes health coverage (medical, prescription, dental), retirement contributions, life insurance, and long-term disability.

II. Departmental Supplies and Related Expense

Adjustments to the supplies/expense budgets and repair/maintenance lines include various realignments within departments and divisions of the University to more accurately reflect appropriate budgetary classifications.

III. Equipment and Other Capital

A fund for capital improvements of \$4,600,000 is maintained as a part of the 2018-19 budget. The adopted State budget for the 2017-19 biennia provides approximately \$1,400,000 of repair and rehabilitation funding for 2018-19 with the expectation that institutions provide additional resources as a part of their respective budgets. These funds will be used to address deferred maintenance and renewal needs of academic/administrative facilities.

IV. Student Scholarships

The recommended student scholarship and fee remission budget for 2018-19 totals \$13,837,428 (or 7.1 percent of the total general fund operating budget). This amount is inclusive of a two percent increase from the 2017-18 level.

The scholarship and fee remission budget consists of two components. The major portion (\$13,637,428) will be awarded directly to students through such programs as the President's Scholars and various other academic and need based scholarships as well as institutional fee remissions for undergraduate and graduate students. The second portion (\$200,000) of the budget accounts for matching funds needed for federal student aid programs.

An additional component of Student Scholarships is the laptop scholarship program for incoming freshman and transfer students with a minimum 3.0 GPA. Base funding of \$1,415,000 is provided in a separate student aid allocation.

V. Academic Debt Service

The State of Indiana provides a separate appropriation (known as *fee replacement*) to offset the principal and interest on student fee bonds used to finance academic facility projects authorized by the General Assembly, reviewed by the Commission for Higher Education, and approved by the State Budget Committee. Institutions are required to issue debt associated with these facilities and pledge student tuition dollars as repayment. The State than replaces the pledged tuition through a *fee replacement* or debt service appropriation.

The payment of fee replaced and non-fee replaced academic debt service is included as a direct expense line in the General Fund budget offset by the Academic Debt Service appropriation and other income in the revenue section of the budget. The increased amount reflects debt service for the renovation of Hulman Center.

VI. Reserves

An allocation of \$1,552,808 was set aside as a part of the 2017-18 budget to fund high priority strategic initiatives. During the past fiscal year \$693,836 of this amount was allocated to support base budget needs of strategic importance. An additional \$300,000 has been added to the reserve pool for strategic initiatives as a part of the 2018-19 budget.

A second reserve pool of five percent of gross student tuition is set aside to absorb any revenue shortfalls. For the 2018-19 year, this amounts to \$5,374,000.

As previously mentioned, for the 2017-19 biennia, the State of Indiana is allocating \$2,350,000 each year in a special appropriation for Student Success Initiatives to assist Indiana State in the continuation and expansion of degree completion efforts. Of this amount, \$1,219,007 is set aside as a reserve to support ongoing initiatives.

STUDENT ACTIVITY BUDGET

The Student Activity budget allocates a portion of student tuition to operating units within the Designated and Auxiliary fund groups to support student activities and related programs. These funds are primarily used to offset increased operating costs for those units supported by the Student Activity budget. Included for 2018-19 is an increase of \$297,000 in the allocation of student tuition to support student activities and related programs.

AUXILIARY AND OTHER OPERATIONS

Auxiliaries are operated as independent units supporting students and the University in various capacities. Residential Life is the largest University auxiliary unit. Each of the Auxiliary units generates outside revenues to support the individual operating budget of the unit. The financial planning components for the General Fund Operating budget were also used in the preparation of Auxiliary budgets.

As in prior fiscal years, a reserve pool for capital improvements is maintained as a part of the Residential Life budget. This reserve pool will be allocated to planned future improvements for student housing and dining facilities.

LINE-ITEM APPROPRIATIONS

The state maintained the same level of support for Degree Link, a separate line item appropriation, as during the 2017-18 year of \$446,438. The appropriation is accounted for in a separate cost center budget to support the delivery of Indiana State University baccalaureate degree programs at Ivy Tech Community College and Vincennes University locations.

Other line-item appropriations allocated to the University for 2018-19 include; \$204,000 for the ISU Nursing Program, \$180,750 for Dual Credit programs (based on State formula), and \$600,000 for the Indiana Principal Leadership Institute operated by the Bayh College of Education.






INDIANA STATE UNIVERISTY Budgeted Revenues by Source - General Fund Fiscal Year 2018-19

3d2 Modification of Policy 630 Purchasing Policy

For fiscal years beginning on or after December 26, 2017 non-Federal entities are required to implement new procurement standards for federal awards as promulgated by the Office of Management and Budget (OMB) in guidance titled "Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards". The 630 Purchasing Policy modification, incorporating the OMB standards, also includes an increase in the maximum transaction limit for procurement cards from \$1,000 to \$1,500 and the monthly total limit, per card, from \$3,000 to \$3,500 unless purchasing volume or activities warrant higher limits.

The current Purchasing Policy can be found in the University Handbook section 630 https://www.indstate.edu/handbook/600-financial-business-affairs/630. Current policy 630 will be replaced with the proposed modified policy, as included below.

Proposed Policy 630 Purchasing Policy

630.1 General

The Purchasing and Receiving Department has been charged by the Board of Trustees with the responsibility for the procurement of all materials, equipment, supplies, contracted services, central receiving, and the disposal and sale of surplus materials and equipment. Purchasing and Receiving is delegated authority to develop and enforce Purchasing Procedures consistent with this policy. Additionally, the Board of Trustees has authorized purchases by University Departments that use the ISU procurement card, and has delegated authority to establish procurement card program rules for University personnel and departments. The procurement card guidelines can be found at: indstate.edu/purchasing/ProCard/Pcard.htm

- **630.1.1 Sole Authority.** The Purchasing and Receiving Department has the sole authority to order materials, equipment, goods, and services on behalf of ISU and obligate the University for purchase of same, except for purchases made through the procurement card program or as set forth in University Handbook Policy 620. Any purchases, whether written or verbal, will be recognized only if authorized by or through the Purchasing and Receiving Department, or as a result of the proper use of the procurement card system.
- **630.1.2 Procurement Standards.** Procurement shall be conducted according to Indiana law and, where applicable, Federal law. State law requires that state educational institutions provide the State of Indiana with vendor lists to determine if vendors have an Indiana registered retail merchant certificate and are not delinquent in paying gross retail and use taxes.
- **630.1.3 Contracts, Or Items Not Handled by Purchasing.** Contracts other than those identified in this policy are governed by University Handbook Policy 620.
- **630.1.4 Emergency Procurement.** Emergency procurement procedures may be conducted as provided for in IC 5-16-1-1.6.
- **630.2 Procurement Methods.** ISU has four basic methods available for procurement: Procurement Cards; Purchase Orders, generated from Requisitions; Direct Payments, generated from a Check Request; and Sole Source Procurement (Noncompetitive Proposals).
- **630.2.1 Procurement Cards.** The standard ISU Procurement Card maximum transaction limit shall be \$1,500, with a maximum total monthly purchase limit of \$3,500. The maximum transaction limit and the monthly total limit may be higher for some departments whose purchasing volume and/or activities warrant higher limits, if requested by a department head, and if approved by the Purchasing Department. The procurement cardholder shall only be required to obtain one quote/proposal, provided that the cardholder determines that the price obtained is reasonable.
- **630.2.2 Purchase Orders and Requisitions.** Purchase Orders may be used for any size purchase and should be used when a transaction amount exceeds a user's procurement card limit.
- **630.2.3 Direct Payments.** Direct payments in the form of a Check Request should be used to pay vendors when a purchase order is not required, when a procurement card cannot be used, or to reimburse employees for items purchased on behalf of the University. Employees should receive advance approval from their supervisor before spending personal

funds for University purposes. Purchases not eligible for reimbursement include payments for contracted services and any other unallowable expenditure.

630.2.4 Sole Source Procurement (Operating and Restricted Funds). Sole Source is the solicitation of a proposal from only one source when <u>one</u> or more of the following circumstances apply:

- ISU has determined that the good or service is only available from a single source.
- For restricted funds where the Federal awarding agency or pass-through entity expressly authorizes noncompetitive proposals in response to a written request from the non-Federal entity.
- In the case of an emergency.
- After solicitation of a number of sources and the competition is determined to be inadequate, or when only one bid was received.

ISU Purchasing and Receiving may require documentation from the requisitioning department in order to justify why the characteristics inherent in a particular item or service makes it essential to the project and in preference to any other offers. ISU shall always be open to proposed alternates, provided that the end user determines that an alternate will meet their needs. Final responsibility in determining whether an item is truly a proprietary item and may be purchased from a sole source rests with the ISU Purchasing and Receiving Department.

630.2.5 Departmental Authorization. The Department Chair, or the Administrative Head responsible for the appropriated funds, or their authorized designee, must approve all Requisitions and Check Requests.

630.3 Policy on Bidding.

- **630.3.1 Operating Funds**. Operating Funds are funds that do not have a third party restriction for a specific purpose and the source of these funds come generally from the State of Indiana, student tuition and fees, or other budgeted operating funds. Indiana State University abides by the laws of the State of Indiana regarding procurement when using operating funds.
- **630.3.1.2 Purchases Under \$3,500.** Purchases may be made on either the Procurement Card, as dictated by the cardholder's limits, or by Purchase Order, without soliciting quotations, if the price is considered reasonable. There may be instances however where the buyer of items at this dollar level may want to verify pricing in some manner.
- **630.3.1.3 Purchases \$3,500 or Higher.** The Purchasing Department shall attempt to obtain a minimum of at least three written quotes from vendors on Indiana State University forms.
- **630.3.1.4 Public Works Projects.** Public works projects (construction, renovation etc.) are advertised and competitively bid in accordance with laws of the State of Indiana..
- 630.3.1.5 Standing Purchase Orders. A Standing Purchase Order is a purchase order which stays open for a period of time (for example for a fiscal year) permitting multiple invoices to be billed against the standing purchase order number throughout the period. When the materials and/or labor can be identified and is measurable, then the Purchasing Department will solicit bids in order to establish the cost of the time and/or materials for the period of time specified. Where the item to be purchased is not known ahead of time, a standing purchase order will be established with instructions to the supplier stating ISU's expectation that any volume discounts are to be applied.
- **630.3.2 Restricted Funds.** Restricted funds are defined as projects that have been externally funded, have been restricted to a specific purpose, and are generally funded by either federal, state, or private funds. Indiana State University abides by the federal guidelines regarding procurement when using federal grants and restricted funds according to Federal Uniform Procurement Guidance 2 CFR 200.320. All University personnel are required to abide by the determination of the Senior Vice President for Administration and Finance or designee in the use of restricted funds.

- **630.3.2.1 Standing Purchase Orders and Restricted Funds.** Standing Purchase Orders cannot be used when restricted funds are to be utilized.
- **630.3.2.2 Purchases \$3,500 Or Under (Micro-Purchases) Using Restricted Funds.** Purchases may be made on either the Procurement Card (up to a maximum per transaction amount of \$3,500.00) or by Purchase Order, or by Direct Pay, without soliciting quotations, if the price is considered reasonable.
- **630.3.2.3** Purchases Between \$3,501 to \$150,000 (Small Purchase Procedures) Using Restricted Funds. The Purchasing Department shall obtain a minimum of at least two quotes from vendors. If only one quote can be obtained, the procurement transaction will automatically be defined and identified as a Sole Source purchase.
- **630.3.2.4 Competitive Proposals Greater Than \$150,000 (Non-Public Works) Using Restricted Funds.** The technique of competitive proposals is normally conducted with more than one source submitting an offer, and either a fixed price or cost-reimbursement type contract is awarded. It is generally used when conditions are not appropriate for the use of sealed bids. If this method is used the following requirements apply:
- ISU shall perform a cost and price analysis with every procurement in excess of \$150,000, including contract modifications. Cost estimates will be made prior to receiving bids or proposals.
- If Restricted Funds are to be used, the requesting department must contact the Purchasing Department prior to the solicitation of proposals in order to identify the evaluation factors and their relative importance that will be used to evaluate project proposals and which are to be included and shown in the Request for Proposal.
- Purchases over \$150,000 are to be publicized by posting a Notice to Bidders on Indiana State University Purchasing Department web site.
- Proposals must be solicited from two or more qualified sources. If only one proposal is received the procurement transaction will automatically be defined and identified as a Sole Source purchase.
- Contracts must be awarded to the responsible firm whose proposal is most advantageous to the program, with price and other factors considered.
- **630.3.2.5 Sealed Bids Greater Than \$150,000, (Public Works Projects) Using Restricted Funds.** Public works projects (construction, renovation etc.) using Restricted Funds are advertised and competitively bid in accordance with the laws of the State of Indiana provided that the procurement conforms to applicable federal law. ISU must perform a cost and price analysis with every procurement in excess of \$150,000, including proposed alternates. Estimates must be made, before receiving bids or proposals.

Public Works Projects (construction, renovation etc.) are advertised and competitively bid. This process includes development of complete specifications, public notice, sufficient lead-time prior to bid opening, and the public opening of sealed bids. ISU reserves the right to accept or reject any or all bids, and the award shall be made to the lowest and best bid, based upon written documentation from the end user. Value engineering, which is a systematic analysis of each contract item or task to ensure that its essential function is provided at the overall lowest cost, may be used by ISU in determining the bid awardee

- **630.3.3 Immediate Action.** Certain situations, circumstances, standardized sources, and/or emergency requirements may demand flexibility and/or an immediate solution. The buying staff is expected to interpret, adequately document and handle purchases in the best interests of the University.
- **630.3.4 Pre-Bid Agreements Established by Outside Entities.** ISU may award a contracts to a vendor, or service provider, where the bidding and overarching contract has been established by an outside organization such as the Federal Government GSA contract, State Government contract, or organizations such as E&I Cooperative (procurement cooperative owned by the Universities in the U.S.), Midwestern Higher Education Compact (MHEC), U.S. Communities (cooperative purchasing program for schools & government), or comparable organizations as determined by the Purchasing Department.

630.3.5 Time & Materials Contracts. ISU may use a time and material type contract after it has been determined that no other contract is suitable. The ceiling price of the time and materials contract shall be specified on ISU's Purchase Order.

630.4 Board of Trustees Reporting. Items to be reported to the Board of Trustees include sole source purchases of more than \$50,000, single purchases of more than \$50,000 if a bid other than the low bid was accepted; and accumulated expenditures by vendor in excess of \$250,000 during the fiscal year.

630.5 Prepayment of Orders. Payment for goods or services shall not be tendered until requested goods or services have been received and approved by the requesting department. The following exceptions exist:

- Payments to local, state, and federal government entities.
- Any procurement of goods or services where the source provides an instrument of security.
- Where the funding agency has authorized prepayment.
- Service and maintenance contracts where necessary.

630.6 Architectural/Engineering (A/E) Services. The Purchasing and Receiving Department may use competitive proposals for qualification-based procurement of architectural/engineering (A/E) professional services whereby competitor's qualifications are evaluated and the most qualified competitor shall be selected, subject to negotiation of fair and reasonable compensation. The method where price is not used as a selection factor can only be used in procurement of A/E professional services.

630.7 Suspension and Debarment. Non-federal entities are subject to the non-procurement debarment and suspension regulations implementing Executive Orders 12549 and 12689, 2 CFR part 180. These regulations restrict awards, sub-awards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in Federal assistance programs or activities.

630.8 Non-Discrimination and Other Laws

Vendors must comply with, Executive Order 11246 as amended that prohibits discrimination on the basis of race, color, religion, sex, sexual orientation, gender identify or national origin.

630.9 Minority, Women, Veteran Owned Business Procurement. Indiana State University is committed to providing minority-owned, women-owned and veteran-owned vendors and contractors every opportunity to compete for ISU business. Efforts will be made to identify, solicit quotes, and communicate with minority-owned, women-owned and veteran-owned vendors and contractors regarding the University requirements and the purchasing process, so that they may become more viable suppliers. Procurement shall be conducted according to the Governor's Commission on Minority Business Development (IC 4-13-16.5 as amended), Indiana Veteran Owned Small Business program (IC 5-22-14-3.5 as amended) and Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards in 2 CFR 200.320 as amended, concerning minority, women, and veteran owned business enterprises. ISU's goals for Veteran Owned Business shall be the same as those established by the State of Indiana's Indiana Department of Administration (IDOA). ISU's goals for the Minority Business Development Program shall be the same as those established by the Governor's Commission.

630.10 Release of Procurement Information. For details concerning the release of procurement information see IC 5-14-3-3 (Right of public inspection of public records).

630.11 Sales Tax. The University is exempt from Indiana sales tax (and sales tax in other States where recognized), local sales tax, and local use tax. When requested, the Purchasing and Receiving Department will furnish a copy of the University's tax-exemption certificate to ISU vendors and contractors.

630.12 Reciprocity. Indiana State University personnel will not participate in reciprocal purchasing arrangements. Indiana State University shall continue to separate purchasing considerations from the objectives of fund raising endeavors of the institution.

630.13 Code of Ethics. The Purchasing and Receiving staff shall abide by the Code of Ethics of the National Association Educational Procurement (NAEP), as may be modified.

630.14 Conflict of Interest. ISU Purchasing Policies shall follow University Handbook Policy 912 Conflict of Interest, as well as adhere to IC 35-44.1-1-4 (Conflicts of Interest Involving Public Servants), and 2 CFR 200.112 and 200.318, which governs conflicts of interest in the use of federal funds.

630.15 Purchases for Employees. Indiana State University's Purchasing and Receiving Department shall not acquire goods or services for the personal use of employees.

630.16 Disposal and Redistribution of University Property. When an item no longer is wanted by a user department, the Purchasing and Receiving Department will attempt to redistribute the item within the University based on equitable criteria. Should there be no need for the item within the University, it may then be sold or traded outside the University. University property purchased with Restricted Funds may require prior approval before being reassigned to another area or being disposed of during the life of the externally funded project and after the project has ended. Consultation with the Office of Contracts & Grants should occur prior to disposal or redistribution.

630.17 University Name, Logo, and/or Marks. Use of the University name, logos, insignia, and/or marks is prohibited without the consent of the University's designee or agent. Items sold utilizing the trademarks of the University without the approval and license shall be subject to seizure and legal action by the University. Use of University marks for commercial purposes is subject to a license, which may be obtained by contacting the Office of Communication and Marketing.

Recommendation: Approve Policy 630 Purchasing Policy as shown above, effective July 1, 2018.

3d3 Year-End Closing Authorization

The State Board of Accounts has advised that the Treasurer of Indiana State University obtain approval from the Board of Trustees to make various year-end closing entries. These entries normally consist of transfers, adjustments, and consolidations necessary to ensure the elimination of minor budgetary overdrafts, and the write-off of bad debt. The closing of the financial records is guided by GASB accounting and reporting standards and best business practices.

Recommendation: Authorization of the Treasurer or designee to make all necessary year-end closing entries and distributions.

3e Modification to University Handbook

3e1 Modification to Policy 932 Data Security and Management

Rationale: The ISU administration recommends a modification to University Handbook Policy 932 Data Security Policy, which will be renamed Policy 932 Data Security and Management. The policy was significantly modified, reviewed extensively by various administrative units, and approved by Faculty Senate. The revisions update the policy to ensure that ISU manages data and data security in accordance with best practices. Specifically, the revised policy identifies data classifications and updates the requirements for access to and handling of ISU data. The administration supports this modification to Policy 932.

Proposed Policy

932 Data Security and Management

932.1 Institutional Data and Obligations

Institutional data are a valuable resource to Indiana State University. The environment for data security is complex and constantly changing. A variety of federal, state, and industry regulations establish both personal and institutional responsibility for data security. In addition to these, ethical and professional considerations create an obligation for all members of the ISU community to care for institutional data with the highest levels of awareness and best practices.

932.1.1 Scope. Data are considered to be University resources and as such, policies controlling the creation, receipt, transmission, processing, use, storage, printing, or dissemination of data are set by the University. These policies will be augmented as needed by specific standards and procedures that will apply at the institutional level. Nothing in this policy shall negate the provisions of University Handbook Policy 370 Intellectual Property.

932.1.2 Definition of Institutional Data. Indiana State University institutional data are data that are:

- Created, received, processed, transmitted, or stored as a result of educational, clinical, research, patient-care, or service activities; or
- Substantive, reliable, and relevant to the planning, managing, operating, documenting, staffing, or auditing
 of one or more major administrative functions of the University; or
- Used to derive any data element that fits the above criteria.

This definition applies regardless of the form or medium on which the data are created, received, processed, transmitted, or stored.

932.2 Types of Data.

In order to communicate clearly about data management practices, it is necessary to recognize that there are different categories and classifications of institutional data

932.2.1 Categories of Data. Data categories are defined based on the function and/or use of institutional data. General institutional data categories include:

- Alumni data
- Contracts and grants data
- Research data
- Employee and benefits data
- Facilities data
- Faculty data
- Financial and budget data
- Health data

- International programs data
- Library data
- Purchasing and travel data
- Student and applicant data
- Instruction-related data
- **932.2.2 Classifications of Data.** Data classifications are defined based on the need to ensure the security and privacy of institutional data. Data classifications are:
- **932.2.2.1 Public Data.** Information and data that are intended for public view.
- **932.2.2.2 University-Internal Data.** Data used internally to University operations or with selected University appointees or partners for ISU business purposes. Access to University Internal Data should be determined based on the job responsibilities of the employee, appointee, or partner.
- **932.2.2.3 Restricted Data.** Data that are sensitive or confidential and, as a result, require specific authorization for access.
- **932.2.2.4. Highly-Restricted Data.** Highly confidential data that, if released, could result in criminal or civil penalties, identity theft, personal financial loss, or invasion of privacy.

932.3 Access to and Handling of Data.

All ISU employees are responsible for handling institutional data properly based on its classification. Data handling includes all activities associated with the creation, storage, transmission, printing, backup, retention, disposal and publication of ISU data.

932.3.1 Control of Data Access.

- **932.3.1.1** Access. Access to data other than public data shall be accomplished through the use of usernames (ID) and passwords. Elements used to control access to data (like IDs and passwords) are not to be shared with other employees. As noted above, data dissemination is driven by 1) the classification of the data, and 2) the need to know.
- **932.3.1.2 Supervision of Students.** Students who access ISU data other than public data will be supervised by full-time ISU personnel; student and student employee access to data other than public data shall be the responsibility of the full-time employee responsible for supervision of the student or student employee. Students and student employees are required to complete appropriate training in order to have access to non-public University Data.

932.3.2 Data Handling and Use.

Users of institutional data must:

- Access data only related to their conduct of University business, and in ways consistent
 with furthering the University's mission of education, research, and public service
- Respect the confidentiality and privacy of individuals whose records they may access
- Observe any ethical or legal restrictions that apply to the data to which they have access

 Abide by applicable laws, regulations, standards, and policies with respect to access, use, disclosure, retention, and/or disposal of information

Users of institutional data must not:

- Disclose data to others except as required by their job responsibilities
- Use data for their own or others' personal gain or profit, except as set forth in <u>University Handbook Policy 370 Intellectual Property</u>.
- Access data to satisfy personal curiosity.

University procedures for data handling are provided in the Indiana State University Data Storage Policy Matrix, documented as part of Office of Information Technology standards.

932.4 Export Control for University Data

Indiana State University and its faculty, staff, and students must comply with all United States export control laws and regulations. Export control laws cover data as well as equipment and other assets. Faculty, staff, and students are responsible for understanding whether data they are working with are covered by export regulations, when there is a need to share data with or expose data to individuals outside the United States. The Office of the Provost can advise on the requirements for specific data.

932.5 Data Security Incidents.

932.5.1 Definition of a Data Security Incident. A data security incident is an occurrence, threat, or possible compromise involving institutional data that are not Public Data. Such a threat may be associated with a hardware component (e.g. a laptop, a smartphone) or an account. Quite often, such incidents occur when a virus or malware infects an institutional computer, and the data on or accessible to that device or the accounts that are used on that device are subject to compromise as a result. In other cases, an action taken by an employee or student, such as theft, loss, or exposure of printed materials containing institutional data that are not Public Data, may constitute a compromise.

932.5.2 Discovery of a Data Security Incident. Discovery of a possible data security incident may occur in a variety of ways:

- 1) ISU security or other software or network protocols may demonstrate that a possible compromise has occurred
- 2) External security agencies may notify us that a possible compromise has occurred
- 3) A computer user may notice unexpected behavior and request assistance from support resources, who discover that a possible compromise has occurred
- 4) Transactional or procedural activity may reveal that data has been compromised or released.

In some cases, discovery is made by information technology and/or security professionals; in others, discovery may be made by an individual employee and/or that employee's management.

932.5.3 Reporting of a Data Security Incident. In all cases, when a possible data security incident is suspected or identified, institutional employees must report the incident immediately upon discovery. An individual employee should also report to his or her supervisor any incident that appears to relate to a data security breach.

Recommendation: Approve Policy 932 Data Security and Management as modified.

3e2 Modification to Policy 922.4 Appeal Process for Sexual Misconduct Determinations Involving Students

Rationale: The ISU administration recommends a modification of the appeal process for appeals of Policy 922 Policy Prohibiting Sexual Misconduct Sexual Misconduct, Intimate Partner Violence, and Stalking. Currently, appeals go to the ISU President. In keeping with best practices nationally and consistent with efforts to align the process for sexual misconduct determinations with the process for student conduct violations, the administration recommends that appeals be reviewed and decided upon by the Vice President for Student Affairs or designee. This modification only involves appeals of determinations involving student respondents and does not modify existing processes for sexual misconduct involving employees or others.

Recommended Modification.

(The proposed change is in red.)

922.9.4 Appeal. In cases involving student respondents, both the complainant and the respondent will have the opportunity to appeal the decision of the Panel to the <u>President Vice President for Student Affairs</u> within ten (10) calendar days of notification of the Panel's decision. The only basis for appeal is the lack of procedural due process, which is defined as a notice of the investigation and the right to be heard.

<u>Recommendation</u>: Approve modification to Policy 922.4 Appeal Process for Sexual Misconduct Determinations Involving Students.

3e3 Modification to Policy 270.1 President's Council on Inclusive Excellence

Rationale: The President's Council on Inclusive Excellence advises the President on development of policy and recommended action in order to promote and maintain a culture of inclusive excellence. The Council also serves as the diversity committee required by Indiana law. The charge and composition to the committee have been updated to reflect current practice, and the administration seeks to include the President's Council on Diversity in the University Handbook section on University Committees.

270.1 President's Council on Inclusive Excellence. The president's Council on Inclusive Excellence serves in an advisory capacity to the President on the development of policy related to diversity issues and development of recommended actions to promote and maintain a culture of inclusive excellence. In addition, the Council fulfills the statutory requirement for a "diversity committee" and is charged with completing the tasks required by IC 21-27-5-4, which are: 1) review and recommend faculty employment policies concerning diversity issues; 2) review faculty and administrative personnel complaints concerning diversity issues; 3) make recommendations to promote and maintain cultural diversity

among faculty members; and 4) make recommendations to promote recruitment and retention of minority students. The Council will also work collaboratively with offices and organizations across campus designed to serve underrepresented minorities including but not limited to the Charles Brown African American Cultural Center, Multi-Cultural Programming, the Center for Global Engagement, the Disability Services Advisory Committee, Veteran Services and various resource centers within Student Affairs such as the Women's Resource Center, the LGBT Resource Center, etc.

270.1.1 Membership. The Council's membership includes two (2) faculty, two (2) staff, one (1) undergraduate student, one (1) graduate student, one (1) community member, five (5) at-large appointments that may be faculty or staff, and one (1) representative from each of the three (3) affinity groups (Asian Pacific/Islander, Black Faculty and Staff, and Hispanic/Latino Faculty and staff). Ex-officio members include the Associate Vice President for Inclusive Excellence, the Director for Equal Opportunity/Senior Deputy Title IX Coordinator, and a representative of the Office of Human Resources.

270.1.2 Nomination. The Faculty Senate shall submit two nominations to the University President for each vacant faculty position, and the Staff Council shall submit two nominations for each staff vacancy. The Student Government Association shall submit two nominations for the undergraduate student representative. The Graduate Student Association shall submit two nominations for the graduate student representative. Each affinity group shall submit two nominations for their representative when vacant. Nominations shall be submitted by May 15th of each year. Nominations, including self-nominations, from campus will be solicited from campus for the at-large positions.

270.1.3 Appointments. The University President will make the faculty, staff and student appointments from the nominations submitted by the governance units and affinity groups. The community and at-large representatives will be selected by the President in consultation with the Associate Vice President for Inclusive Excellence.

270.1.4 Terms. Faculty, Staff, Affinity Group, and Community Representatives will serve three-year staggered terms. Individuals who have completed one term of service may be eligible to be nominated for a second three-year term. Upon completion of a second term, the individual cannot be nominated for at least one year. Students serve a one-year term and are eligible to be nominated for additional terms as long as they remain a full-time student. Terms run from July 1 through June 30.

270.1.5 Voting. All members of the committee, including ex-officio members, have voting rights.

270.1.6 Leadership and Oversight. The president will select the Chair of the President's Council on Inclusive Excellence and will provide the annual charge to the Council at its first meeting of the year. The Committee reports to the President and the Provost through the Associate Vice President for Inclusive Excellence and will provide an annual report to the Office of the President and the Provost by June 30th of each year detailing its meetings, attendance of members, matters acted upon or considered during the year, and the four items required by IC 21-27-5-4, as detailed above in Section 270.1.

Recommendation. Approve modification to Policy 270.1 President's Council on Inclusive Excellence.

3e4 Modification to Policies 305.17 and 305.15.6.1

Rationale: The ISU Faculty Senate proposes an update to the language to Policy 305.17, which sets for the process for appeals of non-renewal during the probationary period and denials of promotion and tenure. The modification sets forth the

timing of the appeal. The Faculty Senate also proposes an update to Policy 305.15.6.1 to provide clarification to the process for early promotion and tenure applications. The administration supports these modifications.

Current Language of 305.17

305.17 Appeals.

Recommendations of non-renewal during the probationary period and denials of promotion and tenure may be appealed to the University Promotions and Tenure Oversight Committee, the formal hearing body for such appeals. Appeals may be made only on the basis of a) inadequate consideration of the submitted materials bearing on the relevant performance of the candidate as stipulated in the prescribed criteria and standards of performance; b) inadequate consideration given to the department's recommendation; or c) violations of academic freedom.

- **305.17.1 Burden of Proof for Appeal.** It is the candidate's responsibility to provide evidence that documents the basis for the appeal. The Committee reviews the entirety of the candidate's faculty evaluation file.
- **305.17.2 Standard of Review.** In appeals alleging inadequate consideration, the Committee shall not substitute its own assessment of academic discipline-specific faculty achievements for that of the department in determining whether or not to recommend the promotion or tenure of a faculty member.
- **305.17.3 Hearing.** If the University Promotion and Tenure Oversight Committee determines that the appeal warrants a hearing, it shall conduct one. The burden of proof rests upon the appellant.
- **305.17.4 Report of Findings.** The Committee shall report its findings, conclusions, and recommendation for or against reappointment, promotion and/or an award of tenure to the candidate through the Provost and Vice President for Academic Affairs, who forwards the Committee's findings and recommendation together with his/her own recommendation to the University President.
 - **305.17.4.1 Negative Recommendation.** If the Committee's recommendation is negative, the candidate may elect to a) terminate the appeal process, or b) prepare a written response, which is forwarded with his/her materials to the University President. In choosing to terminate the process, except in cases of early consideration, a candidate for tenure also withdraws from consideration for further tenured or tenure-track faculty appointment at Indiana State University beyond one (1) academic year following the year of the process. A tenured candidate for promotion who terminates the appeal process may later apply for promotion without prejudice.
- **305.17.5 Continuation of Appeal Process.** Upon notice from the candidate of a decision to continue the appeal process, the Provost and Vice President for Academic Affairs shall forward the Committee's findings, conclusions and recommendation together with his/her own recommendation to the University President. The University President shall confer informally with the Committee before making his/her recommendation.
- **305.17.6 Recommendation by President.** After the findings, conclusions, and recommendation from the University Promotions and Tenure Oversight Committee have been forwarded to the University President, and the University President confers with the Committee and makes his/her recommendation, the appeal process is completed.
- **305.17.7 Decision by ISU Board of Trustees.** The University President conveys his/her recommendation together with the recommendations from the department level review, from the school/college/library level review, from the University Promotions and Tenure Oversight Committee, and from the Provost and Vice President for

Academic Affairs to the ISU Board of Trustees, which makes the final decision regarding promotions and the awarding of tenure.

Proposed Language of 305.17 (modifications are in red)

305.17 Appeals.

Recommendations of non-renewal during the probationary period and denials of promotion and tenure may be appealed to the University Promotions and Tenure Oversight Committee, the formal hearing body for such appeals. Appeals may be made only on the basis of a) inadequate consideration of the submitted materials bearing on the relevant performance of the candidate as stipulated in the prescribed criteria and standards of performance; b) inadequate consideration given to the department's recommendation; or c) violations of academic freedom.

- **305.17.1 Burden of Proof for Appeal.** It is the candidate's responsibility to provide evidence that documents the basis for the appeal. The Committee reviews the entirety of the candidate's faculty evaluation file. The appeal shall be filed with the chairperson of the University Promotions and Tenure Oversight Committee within fifteen (15) days of the Provost's recommendation.
- **305.17.2 Standard of Review.** In appeals alleging inadequate consideration, the Committee shall not substitute its own assessment of academic discipline-specific faculty achievements for that of the department in determining whether or not to recommend the promotion or tenure of a faculty member.
- **305.17.3 Hearing.** If the University Promotion and Tenure Oversight Committee determines that the appeal warrants a hearing, it shall conduct one. The burden of proof rests upon the appellant.
 - **305.17.4 Report of Findings.** The Committee shall report its findings, conclusions, and recommendation for or against reappointment, promoton and/or an award of tenure to the candidate through the Provost and Vice President for Academic Affairs, who forwards the Committee's findings and recommendation together with his/her own recommendation to the University President.
 - **305.17.4.1 Negative Recommendation.** If the Committee's recommendation is negative, the candidate may elect to a) terminate the appeal process, or b) prepare a written response, which is forwarded with his/her materials to the University President. In choosing to terminate the process, except in cases of early consideration, a candidate for tenure also withdraws from consideration for further tenured or tenure-track faculty appointment at Indiana State University beyond one (1) academic year following the year of the process. A tenured candidate for promotion who terminates the appeal process may later apply for promotion without prejudice.
 - **305.17.5 Continuation of Appeal Process.** Upon notice from the candidate of a decision to continue the appeal process, the Provost and Vice President for Academic Affairs shall forward the Committee's findings, conclusions and recommendation together with his/her own recommendation to the University President. The University President shall confer informally with the Committee before making his/her recommendation.
 - **305.17.6 Recommendation by President.** After the findings, conclusions, and recommendation from the University Promotions and Tenure Oversight Committee have been forwarded to the University President, and the University President confers with the Committee and makes his/her recommendation, the appeal process is completed.

305.17.7 Decision by ISU Board of Trustees. The University President conveys his/her recommendation together with the recommendations from the department level review, from the school/college/library level review, from the University Promotions and Tenure Oversight Committee, and from the Provost and Vice President for Academic Affairs to the ISU Board of Trustees, which makes the final decision regarding promotions and the awarding of tenure.

Current Language of 305.15.6.1

305.15.6.1 Exceptions to General 6-Year Rule. Under exceptional circumstances, a candidate in the fourth or fifth pre-tenure year may be considered for promotion and tenure prior to the end of his/her stated probationary period. For this to occur, the candidate's exceptionality must be formally recognized by his/her chairperson's nominating the candidate for early consideration, and the candidate must, in turn, earn the support of every reviewing entity in the process.

305.15.6.1.1 Review Process Stopped upon Negative Recommendation. A negative recommendation from any peer review committee or administrative reviewer stops the review process for early consideration of promotion and tenure. The annual review process continues.

305.15.6.1.2 Right to Appeal. The candidate has the same right to appeal the decision as any other candidate and must follow the same appeal process as defined below.

305.15.6.1.3 Preclusion of Early Tenure. A negative recommendation in either the review or an appeal precludes the possibility of the candidate being given early consideration at a future date but does not terminate employment.

Proposed Language for 305.15.6.1

305.15.6.1 Exceptions to General 6-Year Rule. Under exceptional circumstances, a candidate in the fourth or fifth pre-tenure year may be considered for promotion and tenure prior to the end of his/her stated probationary period. For this to occur, the candidate's exceptionality must be formally recognized by his/her chairperson (or personnel committee when the candidate is a chairperson). Any such nomination for early consideration must be submitted to the Dean before the candidate can pursue an exception to the general six-year rule. The candidate must include this nomination in his/her application for early promotion and tenure. The candidate must also earn the support of every reviewing entity in the process.

305.15.6.1.1 Review Process Stopped upon Negative Recommendation. A negative recommendation from any peer review committee or administrative reviewer stops the review process for early consideration of promotion and tenure. The annual review process continues.

305.15.6.1.2 Preclusion of Early Tenure. A negative recommendation in the review precludes the possibility of the candidate being given early consideration at a future date but does not terminate employment.

Recommendation: Approve modification to policies 305.17 and 305.15.6.1.

3g Geography and Sustainability BA/BS and Anthropology BS

We propose to split the current BS in Human and Environmental Systems (41-54 credit hours) into 2 distinct majors – a BA/BS in Geography and Sustainability (31-34 credit hours) and a BS in Anthropology (42 credit hours). This division will streamline the 2 majors and better delineate the unique identities within the majors and the faculty.

The proposed change stems from concerns voiced by alumni, current students, and administration that the existing major is not a nationally recognized major. The current major with concentrations does not adequately convey to outside funders and potential students and employers the emphasis of the major. We believe this change will better reflect the core content of our programs, enable students to more easily pursue careers in the field, and enhance recruitment opportunities via a nationally recognized degree program.

The proposal has been approved by the Dean of the College of Arts and Sciences, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the 2 new majors, BA/BS in Geography and Sustainability and BS in Anthropology, effective fall 2018.

3h Geology B.S. and Environmental Geoscience BA

We propose to split the current BS in Earth and Environmental Systems (58-69 credit hours) into 2 distinct majors — a BA in Environmental Geoscience (46-49 credit hours) and a BS in Geology (57-59 credit hours). This division will streamline the 2 majors and create an overlap in a core such that a student could easily double major or move between the 2 majors.

The proposed change stems from concerns voiced by alumni, current students, and administration that the existing major is not a nationally recognized major. The current core covers courses typically found in geology degree programs; however, the current degree title does not reflect the core content. Feedback from our students indicate that they are having difficulty

finding jobs in the environmental, mining, and petroleum fields because companies are interested in hiring employees with geology degrees. We believe this change will better reflect the core content of our program, enable students to more easily pursue careers in geology, and enhance recruitment opportunities via a nationally recognized degree program.

The proposal has been approved by the Dean of the College of Arts and Sciences, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the 2 new majors, BS in Geology and BA in Environmental Geoscience, effective fall 2018.

3i Middle School Mathematics Teaching Major

We have been asked to create a stand-alone middle school mathematics teaching major. With the shortage of qualified mathematics teachers in Indiana and the nation, this provides a route to licensure for those who wish to focus on teaching mathematics in the middle school. This major will lead to teaching licensure for mathematics for grades 5-8. Currently students wishing to teach middle school mathematics have one of two routes: the Mathematics Teaching Major (82 credits) which leads to licensure for grades 5-12 or the Elementary Education Major coupled with the Middle School Mathematics Minor (101 credits minimum). For those truly wanting middle school mathematics teaching only, this is a much shorter path, and very doable in 6 semesters. This major will have 69 credit hours.

The proposal has been approved by the Dean of the College of Arts and Sciences, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the new program, Middle School Mathematics Teaching Major, effective fall 2018.

3j Textiles, Apparel, & Merchandising - Merchandising Minor (TAM Majors Only)

The TAM major has been revised to address current industry needs, to align with the meta goal of the International Textile and Apparel Association, as well as to enhance students learning experiences. The changes to the major requirements, focused on providing student with a breath of knowledge that exposes them to the variety of opportunities in the industry but does not specifically address the needs of student interested in the merchandising of fashion goods beyond the basic level. The minor in Merchandising, provides students with the opportunity to explore the business aspects of the fashion industry. In this minor, students will learn about the dynamic processes of developing and marketing fashion goods, distribution channels, sourcing strategies, and retail operations.

The proposal has been approved by the Dean of the College of Technology, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: That the Textiles, Apparel, & Merchandising —Merchandising Minor (TAM Majors Only) be approved and effective fall 2018.

3k Textiles, Apparel, & Merchandising - Design Minor (TAM Majors Only)

The TAM major has been revised to address current industry needs, to align with the meta goal of the International Textile and Apparel Association, as well as to enhance students learning experiences. The changes to the major requirements, focused on providing student with a breath of knowledge that exposes them to the variety of opportunities in the industry but does not specifically address the needs of student interested in clothing and accessory design beyond the basic level. The minor in Design, provides students with the opportunity to explore their creative interest, specific to the fashion industry. In this minor, students will learn about the dynamic processes of constructing clothing, including textile design, pattern-making techniques, garment fit, pattern manipulation, fabric draping techniques for garment construction, and planning and implementing strategies necessary for securing design related career positions.

The proposal has been approved by the Dean of the College of Technology, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: That the Textiles, Apparel, & Merchandising –Design Minor (TAM Majors Only) be approved and effective fall 2018.

31 Financial Services Selling Minor

The content of this minor was designed based on the input from the Sales Advisory council. In addition this particular combination of existing courses provides business students with the NACE competencies of Critical Thinking & Problem Solving, Oral & Written Communications, Collaboration, Professionalism & Work Ethic, and Career Management to prepare them to be career ready. The focus on combining interpersonal and communication skills (sales courses) with analytical and empirical skills (financial services courses) gives our students a unique skill set that will make them more desirable employees and give them a competitive advantage in the hiring process. This program will also encourage students to develop areas where they may have a weakness (interpersonal skills for the more analytically focused, and analytical skills for the more communications focused). This program is a more academically rigorous replacement for the Medical Sales Certificate program.

The proposal has been approved by the Dean of the Scott College of Business, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the new program, Financial Services Selling Minor, effective fall 2018.

3m Elimination Medical Sales Certificate

This program was originally intended to encourage students in business to take science related courses or students in science majors to take sales courses to better position themselves for jobs in the medical sales field. Instead of growing their knowledge, most students are adding this certificate as an afterthought when they realize that their courses in their Sales concentration in the marketing major or sales minor combined with the AHS and science classes gave them the requirements by default. In addition, the certificate has failed to lead to any placements in the various medical sales fields. After consulting with the Sales Advisory Council (including a member from Cook Medical), they raised the fact that the Med Sales Certificate is nebulous and does not provide a unique skill set or a competitive advantage in hiring outside of the sales classes. They recommended that a new minor be introduced to replace this certificate that focused on encouraging students

to obtain in demand skill sets. This resulted in the companion proposal to this one of a Financial Services Selling Minor that focuses on math and analytical skills in addition to sales.

The proposal has been approved by the Dean of the Scott College of Business, Faculty Senate, and has the support of the Provost and Vice President for Academic Affairs.

Recommendation: Approval of the elimination of the program, Medical Sales Certificate, effective fall 2018.







ISU Total Fund Returns Calendar Year Returns Inception Date: October 1, 2010





ISU Tier 2 Returns for Various Time Periods Current Quarter Ending March 31, 2018 Inception Date: October 1, 2010



Revenues

Student Tuition

Student tuition includes debt service from 2017-18 of \$9,038,588 and is offset in the expenditures for Academic Debt Service for the same amount. Fall semester tuition of \$49,137,849 is below budget by \$1,167,225 and Spring semester tuition of \$44,352,461 is below budget by \$1,874,905. The difference partly reflects a decrease in graduate student enrollment and fall to spring return rate for new freshmen. Summer school tuition totals \$4,309,964 which reflects only the second half of summer as this crosses the fiscal year with the remaining portion of summer to be recognized before June 30, 2018.

Other Fees and Charges

Other Fees and Charges are above last year's total by \$20,899. Late registration, change of course fees, deferment fees and undergraduate admission fees are up from the previous year, while collection, on-campus credit, graduate admission and off-campus credit fees are down from last year.

Other Income

Other Income is below last year's amount by \$45,626. This includes an additional \$173,644 of utility reimbursement from Residential Life and a timing difference of \$235,000 recognizing construction project fees in 2016-17 that will be recorded later in 2017-18. Transcript fees are above and indirect cost recovery are below last year's amount.

Expenses

Compensation

Compensation is below last year's amount by \$134,045. Salaries and Wages are down \$121,816 as administrative salaries, overtime and student wages increased while instructional salaries, support staff wages and graduate assistantships decreased. Fringe Benefits are down by \$12,229 due to reductions in medical insurance, PERF and life insurance that offset increases in TIAA/CREF and FICA.

Departmental Expenses

Total Departmental Expenses has increased by \$397,132. Supplies and Related Expenses decreased by \$97,106 due to reduction of office supplies. Repairs and Maintenance reflects an increase of \$602,157 that includes networking maintenance and minor HVAC repair expenses.

<u>Utilities and Related Expenses</u>

Utilities and Related Expenses had a decrease \$354,745 from last year. The natural gas purchase order is lower for FY18. This is also inclusive of decreased water and sewage costs and increased electrical costs.

Equipment and Other Capital

Equipment and Other Capital shows an increase of \$756,632. Library acquisition expenses are up by \$12,982 due to increased electronic subscriptions. Operating Equipment which includes both capital and non-capital equipment purchases shows an increase due to additional computer equipment purchases.

Student Scholarship and Fee Remissions

Student Scholarship and Fee Remissions shows an increase of \$2,053,197. The scholarship expenses reflects a new Illinois scholarship and additional students qualifying for merit-based aid. The Laptop scholarship program expenses were reduced by \$448,183 to reflect lower cost for laptops.

Academic Debt Service

Academic Debt Service was established for FY18 to record debt service for academic facilities that are funded by the State of Indiana. Tuition fees have been adjusted to reflect this change (see Student Tuition).

Budgeted Reserve

For FY18 a budget reserve of 3 percent of the FY17 general fund operating budget was established. The funds will be used to cover the tuition revenue shortfall and additional student scholarships.

Transfers Out

Transfers Out shows a \$297,102 reduction from 2016-17 that is a result of the OIT transfer of \$400,000 to reflect infrastructure upgrades.
